**Notice Inviting Tender for procurement of 35 mm Sensor professional quality full frame Camera with Accessories for Sansad Television**

Sealed Tenders are invited under two bid system viz. **Technical Bid** and **Financial Bid** from manufacturers/ authorized distributors / dealers, hereinafter referred to as agency, **for supply of 35 mm Sensor professional quality full frame Camera with Accessories for Sansad Television as per Bill of Material given in Annexure-I and Technical Specification in Annexure-II.**

**2. Eligibility Conditions**

- (a) The Agency should have **Permanent Account Number (PAN)** under the Income Tax Act, 1961. A copy of the PAN card should be enclosed with the technical bid.
- (b) The Agency should have an annual turnover of Rs.1 (one) crore or above during each of the financial years 2017-18, 2018-19 and 2019-20. **Attested copies of Income Tax Returns and Balance Sheets for these financial years should be enclosed with the technical bid.**
- (c) The agency should have successfully supplied similar items to at least one TV Channel / Production House / Organization during the last two financial years. Documentary proof in this regard along with completion certificate may be given with the technical bid.
- (d) If the Agency is a consortium, a copy of MOU between the partners should be submitted with the technical bid.
- (e) The Agency should have a Letter of Authorization from Original Equipment Manufacturer (OEM) to quote against the tender and for providing after- sales support. A copy of the Letter of Authorisation should be enclosed with technical bid.
- (f) The Agency should not have been blacklisted by any government organization/PSU in the past. **A certificate to this effect should be enclosed with the technical bid.**

**3. The agency should keep the following points in view while submitting its bid:**

- 3.1. Items supplied should be of standard make and model. The model of the equipment should not be nearing obsolescence.

### 3.2 **After sales Service and Training**

The bidder must furnish complete details of the after-sales service arrangements including training to be provided in respect of the equipment. After sales service arrangements should include details of infrastructural facilities available in the country. The training should be made available free of cost at SansadTV, New Delhi or at any other location in Delhi and NCR as directed by this Office. Bidder/OEM shall provide comprehensive after-sales services in India such as repairs, maintenance, supply of spare parts etc. and should be able to provide such services at short notice, irrespective of the presence of its after-sales service centres in India, at least for a period of five years. OEM shall be required to furnish a certificate to this effect.

3.3. Software applications/firmware supplied should be of the latest version. Upgrades to the same shall be provided during the warranty period without any financial implications.

3.4. Agency shall quote only for the intended product and shall not quote for an alternate product.

### 3.5 **Scope of work, Materials and Workmanship**

- (i) Scope of work of the tender is supply of material in good working condition as per Annexure-I
- (ii) Supplier shall fully warrant that all the stores, equipment and components supplied under the ORDER shall be new and of first quality according to the specifications and shall be free from defect (even concealed fault, deficiency in design, materials and workmanship).
- (iii) Should any defects be noticed in design, material and/ or workmanship during guarantee/warranty period as specified in specifications, the Office shall inform supplier and Supplier shall immediately, on receipt of such intimation, depute their personnel within 7 days to investigate the causes of defect and arrange rectification/replacement/modification of the defective equipment at site without any cost to the Office within a reasonable period. If the supplier fails to take proper corrective action to repair/replace the defects satisfactorily within the reasonable period, this Office shall be free to take such corrective action as may be deemed necessary at Supplier's risk and cost after giving notice to the SUPPLIER.
- (iv) Damage to the equipment due to incomplete and erroneous instructions issued by supplier will be responsibility of the supplier and will be treated according to the provision of warranty clause normal wear & tear shall not come under purview of this clause.
- (v) In case defects are of such nature that equipment shall have to be taken to supplier's works for rectification etc, supplier shall take the equipment at his cost after giving necessary undertaking or security as may be required by the Office. This Office shall, if so required by the supplier, dispatch the equipment by quickest mode on "Freight-to pay" basis to the supplier's work. After repairs supplier shall deliver the equipment at site on freight pre-paid basis. All risks in transit to and fro shall be borne by the supplier.
- (vi) Equipment or spare parts thereof replaced shall have further warranty for a period of 12 months from the date of acceptance.

- (vii) The supplier shall guarantee that they will supply spare parts if and when required on agreed price. The agreed price should include but without any limitation to agreed discount on the published catalogue price or on agreed percentage of profits on the landed cost.
- (viii) The supplier will give warranty that before going out of production for any of spare parts, they will give adequate advance notice to the purchaser so that the latter may undertake to procure, if necessary, the balance of the life time requirements.
- (ix) If the repairs, replacement or modification referred are of such nature as may affect the efficiency of the equipment this Office shall have the right to give to the supplier within one month of such replacement/renewal notice in writing to carry out test as may be required for acceptance of the equipment.

3.6 The selected Bidder shall support the hardware & software Solution during the period of warranty as specified in tender document for procurement of Camcorders. During the warranty period, the Bidder will have to undertake comprehensive support of the hardware & Software Solution supplied by the Bidder and all new versions, releases, and updates for all standard software to be supplied to SansadTV at no additional cost. During the support period, the Bidder shall maintain the hardware & Software Solution to comply with parameters defined for acceptance criteria and Bidders shall be responsible for all costs relating to labour, spares, maintenance (preventive and corrective), compliance of surety requirements and transport charges from and to the office in connection with repair/ replacement of the hardware & Software Solution, which, under normal and proper use and maintenance thereof, proves defective in design, material or workmanship or fails to conform to the specifications, as specified.

3.7 During the warranty period, the vendor shall ensure that the services of professionally qualified personnel are available for providing comprehensive on-site maintenance of the camcorders and its components as per the Sansad TV requirement, reloading of firmware/software, compliance to security requirements, etc. when required or in the event of system crash/malfunctioning, arranging and configuring facility as per the requirements of the SansadTV at no extra cost.

3.8 Warranty would be on-site and comprehensive in nature and must have back-to-back support from the OEM/Vendor. The vendor will warrant products against defects arising out of faulty design etc. during the specified support period.

#### 4. **General Conditions**

4.1 **The successful bidder will ensure that the items mentioned in Annexure-I and specification given in Annexure-II mentioned in Technical Bid of this tender document are supplied on-site within 90 days from the date of issue of the purchase order to the full satisfaction of Sansad Television.**

4.2 The equipment should be securely packed to withstand transportation and delivered in perfect condition.

4.3 The equipment shall be under warranty for a period of 12 months from the date of supply of the equipment or standard warranty/ guarantees provided by the OEM, whichever is for more periods.

- 4.4 The agency shall quote for extended warranty for three years after expiry of the initial warranty period as mentioned in **Technical Bid in Part-III(A) and Part-III(B) and in Financial Bid Part-III (A) and Part-III(B) in Annexure-IV.**
- 4.5 The Agency will supply two printed copies of the Technical Manual/Operating Manual with each equipment free of cost. One set of test certificate of each equipment will be required to be enclosed with the shipment.
- 4.6 Only reputed industry-tested equipment and solutions with reliability will be accepted.
- 4.7 All the equipment should meet regulatory compliance, safety requirements and environmental clearances.

## **5. Submission of Bids**

- 5.1 The Agency should submit its bid in two parts, in separate covers, one containing the **Technical Bid** and the other the **Financial Bid**, superscripted accordingly. The sealed Technical and Financial bids should be placed inside a large sealed cover superscripting “**Tender for procurement of 35 mm Sensor professional quality full frame Camera with Accessories for Sansad Television.**” The tender should be addressed to **Director (Sansad TV), Sansad Television, Bungalow No. 21-23 Mahadev Road, New Delhi-110001** and may be dropped in the drop box by **5:00 p.m. on or before 20th June, 2022** or may be sent by courier/registered/speed post so as to reach Sansad Television by **5:00 p.m, 20th June, 2022.**

### **5.2 Earnest Money Deposit (EMD)**

The technical bid should be submitted with an earnest money deposit of **Rs.6,00,000/- (Rupees six lakhs only)**. The EMD should be submitted in the form of a Demand Draft/Pay Order drawn in favour of “**Drawing & Disbursing Officer, Rajya Sabha Television**” payable at **New Delhi**. Tenders without EMD will be rejected. Agencies who have registered under SMES/NSIC exempted under Rule 170 of GFR, 2017 need not submit EMD. EMDs of the unsuccessful agencies will be returned after the completion of the tender process. EMD of successful agencies will be retained as security till 60 days after the completion of supply of the specified items. No interest shall be paid on the EMD. In case the successful agency withdraws or if details furnished by any agency in the bid are found to be incorrect or false during the tender process, his EMD will be forfeited.

- 5.3. **Performance Bank Guarantee** - The Agency whose tender is accepted shall deposit performance bank guarantee of an amount equivalent to the 3% of the total value of contract awarded in the form of Insurance Surety Bond / Demand Draft or Bank Guarantee from any Nationalized Bank in favour of Drawing and Disbursing Officer, Rajya Sabha Television within 15 days from the date of issue of work order by SansadTV. No interest will be paid on the performance Security. Performance surety will be retained by SansadTV for the tenure period of contract and till the expiry of sixty days beyond the date of completion of all contractual obligations.

- 5.4 **Financial Bid** should be given in the proforma attached as **Annexure-IV**. Rate quoted should include delivery of equipment on site.
- 5.5 There should not be over-writing or correction or cutting in the bids and each page of the Technical bid as well as financial bid should be signed by an authorized representative of the Agency.
- 5.6 Firm rates/charges should be quoted in Indian Rupees both in figures and words and should be valid for **180 days** from the date of opening of the bids. Rates and charges should be including of incidental charges, if any. However, rates of GST/taxes may be mentioned separately.

6. **Pre-Bid Meeting**

A pre-bid meeting will be held **on 3rd June, 2022 at 4.00 P.M** in the Office of Sansad TV, Bungalow No. 21-23 Mahadev Road, New Delhi-110001 where the intending bidders may seek any clarifications and visit Sansad Television office to have first-hand information about the requirements of Sansad Television. The intending bidders are requested to make it convenient to attend the pre-bid meeting so that there may not be any communication gap and they are aware of the requirements of Sansad Television.

7. **Opening of Bids**

Technical Bids will be opened **at 4.00 p.m. on 23rd June, 2022** at Sansad Television office, Bungalow No. 21-23 Mahadev Road, New Delhi 110001 in the presence of the bidders or representatives thereof, if any. Financial Bids of only such bidders will be opened who are found eligible in Technical Bid. Time and date of opening of the Financial Bids will be informed to the Agencies which are found eligible in the Technical Bid.

8. The awarding of the contract to the L1 bidder will be subject to fulfil all the relevant terms and conditions as mentioned in the tender document.

9. **Terms of Payment** - Payment of the total order value will be released after supply of the 35 mm Sensor professional quality full frame Camera and accessories to Sansad TV and after providing satisfactory certificate by Technical Section of Sansad Television.

10. **Rejection of Bids**

Canvassing by the bidders in any form, unsolicited letters and post tender overwriting / correction/ wrong calculation in financial bid may invoke disciplinary action and tenders will be rejected. Sansad Television reserves the right to reject any or all of the bids without assigning any reason therefor.

## 11. **Penalty Clause**

Time is the essence of the project and the agency should stick to the prescribed time schedule. In case of late delivery, testing of the equipment the agency shall be liable to pay penalty @ 0.5% of the order value per week of delay or part thereof, up to a maximum amount of 5% of order value, after which the order is liable to be cancelled. Penalty for unsatisfactory service during warranty/ extended warranty period; Liquidated damage for violation of contractual obligations. In the event of non-repair of equipment beyond 60 hrs the agency shall be liable to pay penalty @ 0.5% of the cost of the equipment for each and every week (part of week being treated as full week) of delay until actual performance in addition to recovery of pro-rata maintenance charges for the period which the equipment's remains non-functional; and recovery of cost incurred, if any, by SansadTV for carrying out repair through third party.

## 12. **Indemnity**

The successful bidder shall at all times indemnify Sansad Television towards any loss/damage caused or any claim raised against Sansad Television by any party/third party consequent to this contract. The successful bidder shall be liable, in accordance with the Indian Laws and Regulations for any accident or damage incurred or claims raised against Sansad Television during the period of delivery, testing of the equipment. The successful bidder shall also provide all insurance, including third-party insurance as may be necessary to cover the risk. No extra payment would be made to the successful bidder on this account.

## 13. **Arbitration**

All the disputes and differences arising out or in any way touching or concerning the bid shall be referred to the sole arbitrator appointed by the Sansad Television. The award of such arbitration shall be final and binding on the parties. The arbitration proceedings shall be held at New Delhi.

## 14. **Jurisdiction**

The Courts at New Delhi will have the sole and exclusive territorial jurisdiction over any dispute or difference in connection with this tender.
